The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Second Degree DWI - Operate Snowmobile or ATV Under Influence of Alcohol - Two Priors**

Minnesota Statute: 169A.20.1b(1)

Maximum Sentence: 0-1 year imprisonment and/or 0-\$3000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/25/2015

Control #(ICR#): 15001433

Charge Description: It is a crime for any person to operate or be in physical control of a snowmobile as defined in section 84.81, subdivision 3, or all-terrain vehicle as defined in section 84.92, subdivision 8, anywhere in this state or on the ice of any boundary water of this state when: (1) the person is under the influence of alcohol, two aggravating factors were present when the violation occurred, to wit: two prior alcohol-related driver's license revocations within the preceding ten years.

**COUNT II**

**Charge: Second Degree DWI - Operate Snowmobile or ATV - Alcohol Concentration 0.08 Within 2 Hours - Two Priors**

Minnesota Statute: 169A.20.1b(5)

Maximum Sentence: 0-1 year imprisonment and/or 0-\$3000 fine

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/25/2015

Control #(ICR#): 15001433

Charge Description: It is a crime for any person to operate or be in physical control of a snowmobile as defined in section 84.81, subdivision 3, or all-terrain vehicle as defined in section 84.92, subdivision 8, anywhere in this state or on the ice of any boundary water of this state when: (5) the person's alcohol concentration at the time, or as measured within two hours of the time, of driving, operating, or being in physical control of the snowmobile or all-terrain vehicle is 0.08 or more, two aggravating factors were present when the violation occurred, to wit: two prior alcohol-related driver's license revocations within

the preceding ten years.

**COUNT III**

**Charge: Careless Operation of Snowmobile**

Local Code: LMCD3.11(2)(a)

Maximum Sentence: 0-90 days imprisonment and/or \$0 - \$1,000 Fine

Offense Level: Misdemeanor

Offense Date (on or about): 01/25/2015

Control #(ICR#): 15001433

Charge Description: efendant operated a snowmobile on the ice of the Lake in a careless, reckless, or grossly negligent manner so as to endanger the person or property of another, or at a rate of speed greater than would permit the operator in the exercise of reasonable care, to bring the motorized vehicle to a stop within the assured clear distance ahead.
